WHEREAS, the City of Gulf Shores has requested by correspondence, dated February 8, 2006 and attached as *Exhibit "A,"* that the Baldwin County Commission turn over maintenance responsibilities of the certain roads to the City of Gulf Shores pursuant to conditions set forth in said correspondence, the roads identified as follows:

WHEREAS, the Baldwin County Commission shall provide the City of Gulf Shores a check in the amount of \$116,000.00 for the said foregoing transfer; and

WHEREAS, the Baldwin County Commission agrees to fund a final resurfacing of a one inch overlay (125 lb/sy) at a later date as determined by the City of Gulf Shores with a minimum of 6 months notice; now therefore

BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED, That, as requested by the City of Gulf Shores, the Baldwin County Commission, upon the appropriate resolution being adopted by the City of Gulf Shores and conveyed to the Baldwin County Commission, shall:

1. Turn over maintenance responsibilities of the certain roads to Gulf Shores, said road as follows:



2. Provide Gulf Shores a check in the amount of \$116,000.00 for the said foregoing transfer.
3. Fund a final resurfacing of a one inch overlay (125 lb/sy) of the following roads at a later date as determined by the City of Gulf Shores with a minimum of 6 months notice to Baldwin County. Said resurfacing will include any additional lanes added by Gulf Shores. The City of Gulf Shores will bid the project under the Public Works Law and the cost will be determined by this bid.
