FROM BALDWIN COUNTY COMMISSION


BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF SHORES, ALABAMA, WHILE IN REGULAR SESSION ON JUNE 12, 2006, as follows:

Section 1. That Resolution No. 4049-06, adopted March 27, 2006, is hereby amended to reflect that the City of Gulf Shores only accepts maintenance of County Road 4 West and those local roads as designated in Baldwin County Commission Resolution 2006-72 from the Baldwin County Commission, with the exclusion of County Road 6 West.

Section 2. That the City intends to continue to work with the County to accept County Road 6 West at some time in the future.

Section 3. That this Resolution shall become effective upon its adoption.


