David Conner, County Attorney, said he has a conflict of interest because his firm has represented some of the parties in this LLC at some point and time in the past. Mr. Conner said Mr. Brad Hicks with Stone Crosby, P.C. is here to represent the Commission as Conflicts Counsel.

Joey Nunnally, County Engineer, appeared before the Commission and said staff is recommending the Commission adopt a resolution which approves the vacation of a portion of Brinks Willis Road at the Foley Beach Express. This road is a east/west running route and crosses the Foley Beach Express. In 1999 when the Foley Beach Express right-of-way was acquired, the tri-party agreement between the City of Foley, the Baldwin County Commission and the Baldwin County Bridge Company stated this right-of-way needed to be vacated. That vacation was done, but staff recently found out a strip was not vacated. This will clean up the record by vacating this right-of-way that was not vacated on September 7, 1999.

Chairman Burt opened the public hearing at 9:02 a.m. and asked if there is anyone present who wishes to speak.

There being no requests to address the Commission, Chairman Burt closed the public hearing at 9:02 a.m.

Commissioner Dorsey said the Commission has held the public hearing as required. He also has a conflict of interest regarding this case. This can get a little funny with Commissioner Gruber's absence.
