Public Comments 19-0699

Mr. Calvin Bemis appeared before the Commission and said he is a resident of Bon Secour, Alabama; his family has been there since 1890. There is a public dock there that was built before 1979. Bon Secour fishermen built the dock for the community. The dock could support a semi-truck filled with ice that weighed 300 pounds. Mr. Bemis said now, a person cannot step on the dock. However, the dock is still leased for \$100.00. The dock belongs to the County, but an individual was supposed to maintain the dock and its safety, and this has not been done. The individual has leased the docks all of these years and the residents cannot use it. The wharf used to be 10 x 10, now it is 30 x 70. The right-of-way went all the way down to the dock, now it appears the individual owns all of the right-of-way,

but that is not so, and the residents cannot use it. Mr. Bemis said he would like for someone to come and re-build the dock. When the dock was leased, the individual stated he would maintain the dock, but that has not been done.

Commissioner Ball asked if this is something that will need to be discussed during a work session.

Chairman Gruber said it will not hurt to bring it to a work session. He has spoken with Mr. Bemis. The individual has a lease through the Alabama Department of Conservation and Natural Resources (ADCNR). ADCNR owns the dock, not Baldwin County.

Mr. Bemis said he has the paperwork.

Chairman Gruber said the lease is paid to ADCNR every year.

Mr. Bemis said the individual transferred the lease to his sons.

Chairman Gruber said the lease is still in effect and is leased through the same department.

Mr. Bemis said it will come due again this year, by August 10th.

David Conner, County Attorney, said this was discussed with the previous Commission regarding the ownership, the right-of-way, the property and the dock itself. It will be appropriate to receive the information from Mr. Bemis and bring it back to a work session in order for staff to explain the overlay. Mr. Conner said his recollection was that the State of Alabama, the County and maybe the Industrial Development Board were at play. There were several different agencies involved in that issue. Staff can pull it back up and explain this to the Commissioners, so they can have that background.
