CA1 237th Anniversary of National Purple Heart Day - August 7, 2019

<u>19-1531</u>

Mr. John New, Former Commander of the Southwest Alabama Chapter of the Military Order of the Purple Heart, appeared before the Commission and welcomed the new members of the Commission. Mr. New commented on the origin of the Purple Heart, originally known as the Badge of Military Merit, and the origin of the American flag. He thanked the Commissioners for defending the flag in public and nationally. Mr. New said the Commission should be commended for supporting the Military Order of the Purple Heart, supporting all of the Purple Heart holders in Baldwin County and for its progressive efforts on the veterans' behalf over the years. He thanks the Commissioners from the bottom of his heart.

Chairman Gruber said August 7th is the 237th Anniversary of the Military Order of the Purple Heart. Chairman Gruber encouraged everyone to bow their heads on August 7th and thank the veterans for what they have done during their lifespan. No one would be sitting in this room today, if it were not for the veterans giving everyone their freedom. Chairman Gruber said no one should ever forget that.

Commissioner Ball thanked the veterans for their service and said the Commissioners are proud to support the military, the flag and Military Order of the Purple Heart's organization.

Commissioner Davis said he thanks the veterans for not only what they stand for, but for what Mr. New shared with the Commissioners. It was information presented today that either he had never known or could not recall. It is important for everyone to recall the things that matter about the history and about the future.

Commissioner Underwood thanked the veterans and said it was in January when her office was contacted to inform her there was not a parking sign outside of Central Annex in Robertsdale for the designation of a Purple Heart recipient. Every time she goes to Central Annex, she sees the sign. Commissioner Underwood said every time she sees a car in the parking spot, she wonders who it is. Commissioner Underwood thanked the veterans for all they do and said she has enjoyed seeing them over the last year and a half.

Chairman Gruber thanked the veterans and their organization.

Commander Bill Bergman, of the Military Order of the Purple Heart, appeared before the Commission and thanked the Commissioners for the opportunity to come and speak today. Commander Bergman said it is a pleasure for the veterans to be here.

CA2 Update on Southwest Alabama Workforce Development Council (SAWDC) Activities

Dr. Josh Duplantis, Executive Director, Southwest Alabama Workforce Development Council (SAWDC), appeared before the Commission and said he provided an overall report from SAWDC to the Commissioners a couple of weeks ago. The Commissioners have supported SAWDC for a long time and he wanted to make sure they understood what SAWDC is doing to advance the workforce agenda, not only in Mobile and Baldwin Counties, but also in the nine-county region it represents. Dr. Duplantis presented a slideshow on the Southwest Alabama Workforce Development Council Regional Workforce Development Updates.

Commissioner Ball thanked Dr. Duplantis for his work and said it is great information. It is exciting to see what the future holds for Baldwin County and all of the other counties SAWDC represents. Commissioner Ball thanked Dr. Duplantis for putting the presentation together.

Commissioner Davis said he wants to make the citizens aware and educate the children and parents. He applauds the Chamber of Commerce Gateway Initiative and the hospitality industry. They did something he was really impressed with. The Gateway Initiative celebrated the success of the certification of 176 children who are working now and will be working in the hospitality industry as their first jobs. Commissioner Davis said most people may not still be in the same industry as their first job, but they learned a lot about work and about themselves. He applauds the Chambers for their collaboration. It takes a team to do this. Commissioner Davis thanked Dr. Duplantis for his leadership and said if everyone works together, the children will have a great opportunity. A great opportunity for the children is what it is all about.

Commissioner Underwood said she recently graduated from Leadership Baldwin and her project was on workforce development awareness. She found out that SAWDC is doing an awesome job with the children who are in school. Commissioner Underwood said she found out that people who have not looked for jobs in a while and wanted to enhance their skills were not aware of what was available. Dr. Duplantis' discussion on what skills were of value was interesting because her generation were looked down on if they went to a trade school. They were told they needed to do better than their parents and get a bachelor's degree.

SAWDC has been able to break that stigmatism that a degree is not always necessary to have a great career, life and income. Commissioner Underwood said some of the children who went off to get a higher education are not using it when they returned home. She wants to make sure the children have skills of value and not spending money on a degree that is not benefiting them. There is so much out there that people are unaware of. Commissioner Underwood said SAWDC is making sure everyone continues to know about this.

Dr. Duplantis said he has five teacher institutes this week and it never fails for some of the teachers to follow him out of the classroom after he speaks to them to ask questions.

Chairman Gruber thanked Dr. Duplantis for attending today's meeting and giving his presentation. Chairman Gruber said there are a lot of students who graduate every year, some go to college and some do not. They need to have a direction once they leave high school. There are so many trades in Baldwin County alone that are being lost. The market is high for those trades. Chairman Gruber said it is hard work, but a person could name their price if they went into that field because the demand is so high. Chairman Gruber said a lot of the children will fit into these trades. A lot of the trade school classes should be brought back into the high schools.

CA3 Presentation by the Alabama Free Clinic

19-1502

Ms. Laurie Kittrell, Executive Director, for the Alabama Free Clinic, appeared before the Commission and said people have talked about workforce, the service industry, unemployment rates, but what about insurance. What about people who are chronically ill and cannot afford insurance who do not qualify for Medicaid or Medicare? The Alabama Free Clinic wants to keep those people on the job and working and not in the hospitals. Ms. Kittrell said those people can now come to the Alabama Free Clinic. There are offices in the Health Department in Bay Minette and Robertsdale. There is also a private physician's office in Gulf Shores to visit. The Alabama Free Clinic has partnerships will all three hospitals in Baldwin County. The partnerships allow patients to be seen by the Alabama Free Clinic and out of the hospitals and emergency rooms. There are volunteer doctors, nurses and clerks who help take care of patients at no charge to them. Ms. Kittrell said 87 percent of the patients seen are working people who do not qualify for Medicaid or Medicare. There are approximately 30,000 Baldwin County residents who are uninsured and just over 600 patients in the clinics. Ms. Kittrell said the Alabama Free Clinic has to get the awareness out there. There are so many people who want to work, but cannot because of a chronic illness and the fact they cannot afford the medicine. The Alabama Free Clinic offers all of this for free. It is completely dependent on donations, individuals and grants. It does not receive any Federal funding and it does not charge the patients.

Chairman Gruber said it is a great program provided in Baldwin County. He

appreciates the Alabama Free Clinic stepping up to provide this service. There are a lot of people who are still uninsured. These clinics fill that void and he appreciates it.

Commissioner Underwood said she met Ms. Kittrell a few months ago and did not know what the Alabama Free Clinic was about. There is a reason why people are uninsured, the cost for health insurance is more than some of them make in an annual wage base. Commissioner Underwood said in her profession as a CPA, she sees self-employed people who do everything they can to make it and their health insurance premiums can skyrocket anywhere between \$1,500.00 and \$2,000.00 per month and that comes along with a \$5,000.00 to \$7,000.00 deductible. When the Affordable Care Act came out, it sounded like a good thing, but there was still a high deductible that was an obstacle for someone who made minimum wage to surmount. Commissioner Underwood said people do not realize hypertension and diabetes are included as chronic diseases that can happen from birth. When she found out about the Alabama Free Clinic and its compassion for people and when she saw a video showing people who have benefited from this, it made her feel more people needed to know what is out there and available. Commissioner Underwood said anyone who has a chronic disease or illness can check with the Alabama Free Clinic to see if the clinic can help. There are a lot of people who hang on to jobs they barely like because of health insurance. Commissioner Underwood thanked Ms. Kittrell.

Ms. Kittrell said when the Affordable Care Act came out, she became certified to be a navigator. She thought she could get all of the clinic's patients on insurance. A lot of them got on it, but they came back because they could not afford the medicine or go to a specialist.

Commissioner Ball asked Ms. Kittrell to tell the public the best way to get in touch with the Alabama Free Clinic.

Ms. Kittrell provided the Alabama Free Clinic's website address and phone number.

Commissioner Davis said he commends Ms. Kittrell for a lot of things and he concurs with everything that has been said so far. He has had people come to him to fuss about things that he has no influence over like Doctors without Borders where people think the County is taking care of people in other parts of the world. That is not charity, that is compassion. Commissioner Davis said he also wants everyone to realize, as citizens, that people like Ms. Kittrell and her organization are sharing compassion in the County's backyard. That is vital for everyone to understand and remember that compassion is the new charity. Commissioner Davis said charity is not bad and compassion is even better. He thanked Ms. Kittrell and the Alabama Free Clinic for what they do and likewise, he hopes the public will also look around because everyone knows someone who can benefit

from this. Commissioner Davis said it is about communication and everyone working together.

Chairman Gruber thanked Ms. Kittrell for coming today to make her presentation. He hopes people will see this and visit the Alabama Free Clinic. It is something that was started several years ago, and it does work.

CA4 Presentation by Loxley Bicentennial Steering Committee

Ms. Joan Richardson, Chairman of the Bicentennial Steering Committee, appeared before the Commission and said she appreciates the opportunity to share with the Commission all of the exciting things the Loxley Bicentennial Steering Committee has done over the last three years. Ms. Richardson presented a slideshow update on the Alabama 200 Bicentennial projects by the Loxley Committee.

Commissioner Underwood thanked Ms. Richardson for having the school children to be a part of the Bicentennial events. Commissioner Underwood commented on how she participated in the United States Bicentennial at nine years old and said it is great the children get to be a part of this. It may not all soak in now, but later on, they may embrace the County and the State. Commissioner Underwood said the Baldwin County Bicentennial Steering Committee members have worked hard and she thanks them.

Ms. Richardson said the program with the children was one of her favorites, the children were great. On the way back on the buses, the children were talking about the different things they learned. Ms. Richardson said being Chairman of the committee has been a gift. She has met people she would have never known. The Town of Loxley feels it can do anything and she is thrilled to do this. Ms. Richardson said she appreciates the Commissioners listening to her.

Chairman Gruber thanked everyone who has worked on the 200th Bicentennial. Baldwin County is one of the richest counties with history in the State of Alabama. The sad part is a lot of people still do not know what took place way back when. So much has happened and people do not realize what is here. Chairman Gruber said there is so much history here. He thanks the Bicentennial Steering Committee for this information.

CA5 Presentation - Baldwin County Commission Mobile APP and Streaming Channel

Brian Peacock, Communications and Information Systems (CIS) Director, appeared before the Commission and thanked the Commissioners for allowing the CIS Department to develop this app within the department. The County's website has a tremendous amount of information on it and the department's goal was to provide an application via a mobile device to guickly find information pertaining to

the County. Mr. Peacock gave an online demonstration of the app and said this is version one and it will continue to grow.

Commissioner Ball thanked Mr. Peacock and his staff for working on this project. This is something the Commissioners have looked at for a long time and now it is coming to life. This will be remarkable to have since everything is at a person's fingertips now. Commissioner Ball said later on, the Commission can integrate the banner for emergencies to constantly remind people with updates.

Commissioner Davis thanked Mr. Peacock for this effort. Instead of standing in line to do things, a person can sit at their kitchen table or desk to accomplish a lot of things that take a lot of time and create frustration and anxiety over how and when things get done. Commissioner Davis said the key is to communicate. It is all about relationship building and everyone is in the business of making this better. Commissioner Davis commended Mr. Peacock and his staff for what they do. It is about how to get to what is next and that is what he likes to focus on.

Commissioner Underwood thanked Mr. Peacock and said when she contacted Mr. Peacock several months ago to discuss how people could people get notified about meetings, he said he would work on something. This is awesome and she commends Mr. Peacock and his staff for taking the initiative to get this done. Commissioner Underwood said this is even more than she envisioned. She can see bigger and better things. The Commissioners want as much open and honest government as they can have out there. This is a way to keep the Commission's website safe. There is some awesome information at everyone's fingertips and it can only get better.

Chairman Gruber thanked Mr. Peacock and said the CIS Department has made a lot of major overhauls over the years. They continue to strive for the future. He appreciates staff digging down to get this; this is what the future is all about. Chairman Gruber thanked CIS staff and said he hopes to learn how to use it.

Mr. Peacock said the Commissioners have mentioned this and he can only echo it, he thanks the CIS staff. They work as a team, they do not draw lines in the sand and they are there for each other. This has been a learning effort for them. This is the first time they have done anything with a mobile app development. Mr. Peacock said staff has soared with it and have made it work. He could not be more appreciative of the CIS Department.

Chairman Gruber said it is not only the updates to social media, but staff is also involved with the radio system the Commission took on to manage for first responders to have a better system. The CIS Department is still working to improve this and he appreciates it.

Commissioner Ball asked if staff could work with Joey Nunnally, County Engineer,

and the Highway Department to integrate road closures into the app?

Mr. Peacock said staff was hoping to utilize the general notifications for the app, but they can look at giving the Highway Department a separate section in the application for citizens to check on road closures.

After the motion, before the vote, Chairman Gruber said there are some people present who wish to speak on this issue.

Commissioner Davis asked if the Commissioners can have some discussions, officially?

Chairman Gruber said anyone present who wishes to speak to please be brief. The Commissioners do not want to hear a long lecture, but they do want to hear what the speakers have to say. This is not a public hearing, but the Commissioners want to give people an opportunity to speak.

Commissioner Ball said there is a motion and second on the floor.

Chairman Gruber said he asked for any discussion, but the Commission can go ahead and vote.

Commissioner Davis asked if the Commissioners can do like they normally do and have discussion after the vote? He serves as the point person of the four Commissioners dealing with economic development. The County is growing 17 people per day; that is 6,200 people per year. In five years that will be 31,000 people. Commissioner Davis said his concern is whatever the Commission does and however it is paid for, the County still has to function within those five years while construction goes on. As the transportation on Highway 31 in Spanish Fort has been improving, it has created considerable backlog and difficulties. Commissioner Davis said he would like for the Commission to look at maybe doing this in segments and ultimately getting where the County needs to go because there will be more people coming in the next five years than residents of the City of Daphne. Residents need to recognize the County is not creating a bridge in a vacuum, but is dealing with a crowded situation now. The residents must recognize that as the County moves forward, there will be more people willing to come to and through the County.

After the vote, Dr. Lou Campomenosi with the Common Sense Campaign, appeared before the Commission and thanked the Commissioners allowing him to speak and for adopting the resolution. He thinks the question about the toll can be resolved. Dr. Campomenosi thanked Senator Greg Albritton and Senator Chris Elliott for their leadership in trying to find solutions and for Senator Albritton finding a funding solution. Dr. Campomenosi handed out information to the Commissioners on his group's efforts on "Stop the Toll - For The Mobile Bay I-10 Bridge" and commented on the group's plans hold public hearings to gather information and meet with the Governor of Alabama. Dr. Campomenosi said in working with the Commissioners and Mobile County and others who do the type of public work the Commissioners do, there is a good chance to change this. They have to stay together and work hard to let everyone know they will not put up with ALDOT's "my way or the highway" approach to how they will do the project.

At this time, Commissioner Ball left the meeting and the Chambers.

Ms. Celia Waters with the Common Sense Campaign, appeared before the Commission and said she is a resident of Fairhope. Ms. Waters commented on the wording of the resolution and what she would like to see taken out of it. Ms. Waters commented on the cost of having more than one pass for the toll bridge and the methods of collecting tolls. Ms. Waters commented on what will happen to the County's economy and on the increase of traffic on secondary roads if the toll bridge is approved.

Commissioner Underwood said there are so many questions on this. The last four days of her life have been consumed by this topic. This is just the beginning of

discussions and this now has the Commissioners' attention.

Ms. Waters said there are over 46,000 people who are against the toll.

Commissioner Underwood said in the last four days, she has hardly been able to concentrate on anything else. Discussions have started and the Commissioners are now able to find out more information.

Ms. Waters said whatever happens will affect everyone in the community just the same.

Commissioner Underwood said it is the entire United States.

Ms. Waters commented on an organization that has been fighting the national tolling lobby in the United States.

Commissioner Underwood asked Ms. Waters to forward that information to the Commissioners.

At this time, Commissioner Ball returned to the Chambers and the meeting.

Mr. Jonathan Armstrong, former County Commissioner, appeared before the Commission and said he is not here to lecture or to be disparaging. Mr. Armstrong commented on how weak the resolution is and how the toll will affect everyone. Mr. Armstrong commented on the County's past history with the State. Mr. Armstrong said the Commissioners were elected to represent Baldwin County and asked the Commissioners to change the verbiage to the resolution passed today. Mr. Armstrong said the Commissioners are doing an excellent job.

Dr. Campomenosi said he supports both of the last two speakers and feels the County should go down the no toll road.

Commissioner Davis said he appreciates Mr. Armstrong's candor and straightforwardness on this. He asked that people not take the wording of the resolution to mean that any of the Commissioners are for a toll. The Commissioners want to hear the facts about what led them to this as "the only way to do it." When the Commissioners have to vote whether or not to support a toll, they will vote their convictions. Commissioner Davis said he cannot comfortably vote for a toll when he does not know how it got here and what the other options are. It is very significant as to what the Commission is trying to do. It is not trying to soft peddle it, but at the same time, the Commissioners are trying to make sure the State understands they are representing the citizens of Baldwin County and they need more information. For someone in an appointed slot to say that is the only way to do something, it makes him want to find out if it is true and to find out what the other options are.

Commissioner Ball thanked everyone for their comments and suggestions and said the Commissioners hear them loud and clear.

Commissioner Underwood said she does not want any tolls. The only way to get attention is to do it in a way to get questions answered. There is a dialogue now where there was not before and she has posed some questions and she hopes to get those answers. This is the beginning of an opportunity to get more questions answered. Commissioner Underwood said there is so much the Commissioners have had to learn and this has crept up on them. She encouraged the public to bear with the Commissioners. They know what needs to get done for Baldwin County. With the public's prayers, the Commissioners will make it there.

Ms. Waters asked if the Commissioners have been in discussion with ALDOT or the Governor?

Commissioner Underwood said there are some people who are allowing them to ask questions.

Ms. Waters asked if the public was allowed to know who, to which Commissioner Underwood replied that was not important. Ms. Waters asked if the Commissioners are going to pass another resolution?

Commissioner Underwood said the Commission does not have another resolution to pass, but they could pass another one at every meeting if they want to change or update it. The resolution passed today is the first step, it is the beginning.

Ms. Waters said she is one of the Commissioners' biggest fan and loves reading what they are doing.

Chairman Gruber thanked everyone for their input and said this is the Commission's first "stab" at this. As Mr. Armstrong knows, it is tough sitting up here. There are a lot of things the Commissioners have tried to do and have to explore every avenue out there. A lot of thought has to go into this process. The Federal government's regulations state it has to be built within a 100-year floodplain. He feels the Federal government should pay for this, but it is not going to do it.
