Commissioner Davis said he would like to give a "shout out" to Mobile Infirmary for what they are doing in the Malbis area. The Infirmary is building a 79,110 square foot, \$26 million medical office building that will open in 2021. The building's architecture will be consistent with the Malbis Community. Commissioner Davis said he is proud because this puts health care close to a lot of residents and it is very significant. Commissioner Davis said the Commissioners will soon receive additional information from the Eastern Shore Metropolitan Planning Organization (ESMPO) related to the proposal to move forward with support of a bridge concept between Mobile and Baldwin Counties, basing it on safe capacity increase. This will be presented at the next work session and he hopes the Commissioners will show their support of the efforts by the ESMPO to come up with a way to get the bridge connectivity and hopefully without any type of toll.

Commissioner Gruber said the County has lost another good citizen in Mr. Bobby Faust. Mr. Faust was very supportive within the County. Commissioner Gruber said Mr. Faust is Representative Joe Faust's brother. Funeral services for Mr. Faust will be held tomorrow. Commissioner Gruber said he gives his deepest condolences to the Faust family; Mr. Faust was a true friend to a lot of people. He was an all-around good person and Commissioner Gruber wishes his family the best.

Chairman Underwood said she echoes Commissioner Gruber's comments and sends her sympathies to the Faust family. Mr. Faust was bigger than life person who truly loved all of Baldwin County. Mr. Faust helped a lot of people. Chairman Underwood said Baldwin County will miss a great person in Mr. Faust.
