5) Authorize the County's Sales Use & License Tax Department to proceed based on Ala. Code §40- 2-11(16) with wage garnishments against the taxpayer's salaries, bonuses, commissions, and any other type of compensation from an employer. The wage garnishment remains in effect for subsequent pay periods until the total amount of the garnishment has been withheld and remitted by the employer; and

6) Authorize the County's Sales Use & License Tax Department to proceed with financial institutions garnishments based on Ala. Code §40-29-23. A garnishment may be issued to a bank, credit union and brokerage firm. The County is entitled to receive the full amount of money in account at the time the garnishments served, not exceed the full amount of the tax liability; and

7) Authorize the County's Sales Use & License Tax Department based on Ala. Code §40-29-23 to proceed with Writs of Execution. Writs of execution may be issued to the sheriff where the taxpayer has real or personal property. In the case of real property, the Department will ask the sheriff to offer the taxpayer's right, title, and interest in and to the property to the highest bidder. The property is sold on the courthouse steps subject to any prior encumbrances. The taxpayer will have one year to redeem the property from the Department or the highest bidder by paying the costs of the sale, the total tax liability, and the accrued interest. Whenever personal property is sold, there is no redemption period; and

GA1 Request from Baldwin County Sheriff's Office - Resolution #2020-068 Opposing House Bill 39 and Senate Bill 47 - Issuance of Concealed Carry Permits within the State of Alabama <u>20-0861</u>

Wayne Dyess, County Administrator, read Resolution #2020-068 for the record.

Sheriff Huey Hoss Mack appeared before the Commission and said the resolution

speaks for itself. It specifically addresses only two pieces of Legislation: House Bill 39 and Senate Bill 47; they are companion Bills. Sheriff Mack said the reason he is seeking the approval of this Resolution is because both Bills are in Committee in Montgomery tomorrow. They will be brought up in public hearings of which he will be in attendance. He has been asked to offer testimony in both hearings. Sheriff Mack said these Bills are about public safety, local government, and the safety and convenience of citizens. This past year, the Sheriff's Office issued over 15,000 permits. Residents of Baldwin County have the ability to come to four locations to get a permit: Foley, Fairhope, Robertsdale and Bay Minette. The average turnaround time is 10 minutes or less. Sheriff Mack said under the proposed Bills, all of this would be transferred to Montgomery with the exception of the application process. It would take up to 30 days to get the permit in the mail. If this is transferred to Montgomery, the cost of the permit would increase from \$20.00 to \$25.00 per year and cost the State of Alabama an additional \$2.3 million to set up and manage this system. The County has built its system and it is in place. There are currently over 756,000 concealed carry permits in Alabama and 350,000 of those are renewed every year. Sheriff Mack said under this law, it would place an additional burden on the Alabama Law Enforcement Agency (ALEA) of conducting 500 to 1,000 background checks a day. This past year, he did not receive any complaints on the issuance of the concealed carry permits. The Sheriff's Office denied 221 permits which consisted of convicted felons, convicted sex offenders, people in violation of drugs and protection from abuse orders, people who had criminal records from other states and individuals who were not citizens of the United States or residents of the State of Alabama. Sheriff Mack said there were zero appeals on the denials. Alabama is an "open carry" state and it is a strong 2nd Amendment state. All of this has to do with the business process of the concealed carry permits. If this legislation was to pass, it would move the permit process to Montgomery. As he stated in the work session, all a person has to do is walk down to the Driver License Office to see the back log that is in there. Sheriff Mack said this is best managed at the local level of government, by the Sheriff.

Motion by Commissioner James E. Ball, seconded by Commissioner Charles F. Gruber, to adopt Resolution #2020-068 opposing House Bill 39 and Senate Bill 47 related to the issuance of concealed carry permits within the State of Alabama.
