Brett Garr, Chairman of the Baldwin County Environmental Advisory Committee, provided an update on the Committee's actions since its re-organization, including dirt road projects and the reinstatement of the annual Environmental Awards.

Leslie Graham, member of the Environmental Advisory Committee, discussed the goals for the committee which include quality monitoring of ground water and using ADEM protocols to monitor surface water. Ms. Graham said the main project will be monitoring water quality on the Tensaw and Perdido Rivers and will encompass monitoring of approximately 10 sites over four years, education outreach campaigns regarding pathogens and maintaining septic systems. Ms. Graham said the Committee desires to show support for the Baldwin County Water Monitoring Network Restore Project Submittal, and the progress being made in the construction of a 100-acre facility to build a constructed wetland to treat the water along Bon Secour River.

The Commissioners discussed state boundaries and asked Ashley Campbell, Natural Resource Officer, for information regarding this in order to share it at an executive meeting

with the Mobile Bay National Estuary Program (MBNEP).

Ms. Campbell said she would be attending the meeting as proxy for the Commission.
