Mobile Bay National Estuary Program

Ms. Roberta Swann appeared before the Commission and discussed the Mobile Bay National Estuary Program funding request for Fiscal Year 2021. Ms. Swann and the Commission further discussed the recently shown coal ash film, communicating with the younger citizens the importance of the environment and media outreach regarding the film.

Alabama Cooperative Extension Service

Ms. Katherine Shepard, Coordinator, Baldwin County Extension Office, appeared before the Commission, provided a handout on the **Master Environmental Education** and discussed the Alabama Cooperative Extension Service funding request for Fiscal Year 2021.

ARC Baldwin County

Ms. Kathy Fleet appeared before the Commission and discussed the ARC Baldwin County funding request for Fiscal Year 2021. Ms. Fleet further discussed the programs the ARC Baldwin County provides to citizens, the history between the ARC and BRATS, and ARC's current transportation.

Baldwin County Boys & Girls Ranch

Mr. Jim Harmon, Director of the Baldwin County Sheriff's Boys Ranch, appeared before the Commission and discussed the Baldwin County Boys & Girls Ranch funding request for Fiscal Year 2021.

Senator Chris Elliott appeared before the Commission and discussed the funds set up by the Legislative Delegation to assist with historic sites, the Delegation's intention to match the funds allocated to Fort Mims to the south end of the County. Senator Elliott and the Commission further discussed the condition of the Heritage Museum, the lack of personnel at the Heritage Museum, the requested funds and the allocation of funds to Fort Mims.

Ms. Tammy Kinney with the Baldwin County Heritage Museum participated in the meeting via teleconference and discussed the Baldwin County Heritage Museum funding request for Fiscal Year 2021.

Baldwin County Historic Development Commission

Mr. Mike Bunn, Director, and Mr. Todd Thomas, Board Treasurer of the Baldwin County Historic Development Commission, appeared before the Commission and discussed the Baldwin County Historic Development Commission funding request for Fiscal Year 2021. Further discussion was held regarding the maintenance at the Swift Coles House, the operational expenses and the Baldwin County Historic Development Commission's website.

The Commission requested Wayne Dyess, County Administrator, to determine what is needed to be done at Swift Coles House moving forward.

The Commission and staff discussed the need for accountability from the BCLC board, the County's assistance in providing funds for an audit, the previous walk-in library, the continued need for a walk-in library, locating current underserved areas in the County, getting more public funding and County staff assisting the BCLC.

It was decided that the Commission would appropriate funds for the first quarter; however, the remainder of the appropriation is contingent upon receiving the audited financials from the Baldwin County Library Cooperative.

Baldwin County Soil & Water Conservation

Mr. Frank Trione, Chairman of Baldwin County Soil and Water Conservation; Mr. Joey Koptis, Natural Resource Conservation System District Conservationist; and Ms. Laura Smith, Bookkeeper, appeared before the Commission and discussed the Baldwin County Soil & Water Conservation funding request for Fiscal Year 2021.

Further discussion followed regarding the issues farmers in the County are facing and issues with the lack of emergency watershed protection funding.

Bay Minette Rotary Club

The Commission agreed to appropriate \$500.00 to the Bay Minette Rotary Club to maintain the flags around the Courthouse.

Eye Heart World, Inc. (The Rose Center)

Commissioner Ball discussed appropriating \$2,000.00 to the Rose Center, which deals with child trafficking.

The Commission and staff discussed last year's appropriation and it was decided to approve this year's appropriation contingent upon a representative from The Rose Center attending a work session to discuss the request.




Master Environmental Education















Extension Agent and Volunteer instructors travel throughout Baldwin County to public and private schools to present environmental lessons for 2nd – 12th grades.

The Water Cycle: (2nd-3rd grade) Students will see a "rainstorm" in the classroom. After seeing the demonstration, they will be able to identify the three forms of water (solid, liquid, and gas) and the relationship between surface water and groundwater.

Backyard Wildlife Habitat: (2nd-5th grade) Students will discuss why the population of animals and their habitats are declining and why we should be concerned. Students will identify three things that are essential to a backyard wildlife habitat.

Recycling: (3rd-12th grade) Students learn about solid waste disposal in the county as well as the importance of recycling and composting to reduce the amount of waste in landfills. They discuss concepts like packaging, decomposition and renewable resources.

Groundwater Pollution: (3rd-12th grade) By observing a groundwater model, students will see how water moves through an underground aquifer. The use of colored dyes allows students to visualize the effects of pollutants on groundwater.

Aquatic Nuisance Species: (6th-12th grade) Through the use of photos, the students will discuss the origin and impact of aquatic nuisance species. Students will identify actions to reduce the spread of nuisance species. Energy: (6th-12th grade) Students will discover why it is important to use renewable energy sources instead of nonrenewable energy sources. Students will discuss ways to conserve energy.

Invasive Plant Species: (6th-12th grade) Students will identify the impacts of invasive plants, describe ways to prevent their spread and differentiate between native and invasive plants.

Alabama Water Watch: (6th-12th grade) Students will be introduced to the Alabama Water Watch citizen volunteer water quality program. They will learn how to make visual observations about water quality and how to test physical and chemical characteristics of water to determine pollution sources and long-term trends in water quality.

Stormwater Pollution: (6th-12th grade) Through the use of a watershed model, students will observe the effects of stormwater pollution on water quality. Students will discuss point and nonpoint sources of pollution, the effects on our local waters and preventative actions they can take to create a clean water future for generations to come.

Energy: (4th-12th grade) Students will discover why it is important to use renewable energy sources instead of nonrenewable energy sources. Students will discuss ways to conserve energy.







As you can see, our state aid is slowly rising. For 2020 – 2021 per capita is set at \$1.13 per resident. While we are increasing in the amount we receive, these funds alone do not cover the cost for services provided to a rapidly growing county. BCLC is asking that the County Commissioners' agree to continue matching State Aid as they have done in the past as well as provide funds for a new courier van. Our 14 member libraries would also like to be considered for receiving matches in their State Aid as well.





The Gateway Initiative: A Regional Economic Force... and Growing

Submitted by: **Greg Alexander**, President of the Coastal Alabama Business Chamber

The Gateway Initiative is a rapidly evolving workforce development leader in Baldwin County, and is cutting edge, while still holding true to the core value of "business-driven programming". This initiative is recognized and highly respected within the State of Alabama, having a foundation based on collaboration between the South Baldwin Chamber of Commerce and the Coastal Alabama Business Chamber. In July of 2019, leadership from both chambers came together for the collective good of our business community. The expanded programming model is fundamentally based on meeting the needs of our local businesses through partnerships that include South Alabama Workforce Development Council (SAWDC), Alabama Technology Network (ATN), Development Training Alabama Industrial (AIDT), area colleges & universities along with local business owners and private municipalities.

Collaboration between businesses, educational

organizations and local municipalities within the tri-city area is at an all-time high, and largely due to the influence of the Gateway Initiative. Workforce development, community entrepreneurship, advocacy, betterment. business engagement & acceleration are the components foundational Guided by investors* and key program. stakeholders, what the community needs NOW is provided by the Gateway team, and evolves as the economy demands. There couldn't be a better example of this than the efforts put forth by the Gateway team during the first phases of local impacts seen due to COVID-19. Gateway, in partnership with the Coastal Resiliency and the County Commission Coalition. facilitated daily calls with area leaders (33 todate), combed through the chaos of ever changing information and resources to share daily emails with key resources for business as well as a dedicated website page for these resources.

During this time, Gateway also initiated a project and partnership with One Baldwin to produce update videos, written features, links to news sources, and business story videos on a brand new stand-alone website, gatewayinitiative.com.

The Gateway Initiative continues to offer services and programs, like individualized customer service training, direct links to elected officials in Montgomery and Washington D.C. (through collaboration with the Baldwin County Chamber Coalition), business plan review, advertising and marketing services, advocating for local education to better fit industry. recruitment activities like job and hiring fairs, industry survey development administration, a source for community news and updates...and much more (see page 8 for a full list of solutions)! One key component of the Gateway Initiative is its sponsor status for apprenticeship opportunities in County. To date, Gateway has helped local businesses establish apprenticeships in 14 businesses, for 16 position types, and for 57 individuals. Apprenticeship allows a business to receive tax credits and other incentives, all while creating a culture of career advancement within each establishment. Apprenticeship Signing Day, held in March of 2019, paired local businesses with area high school students for summer employment. This was a hugely successful event, with 179 participants, and ultimately 96 students 'signing' on as employees or apprentices! However, many businesses lost their signees as a result of transportation availability in the region something Gateway has pledged to work alongside other advocacy groups to tackle during the next phase of the campaign (see pages 12-14 for the 2020-2021 Accountability Plan). The community fervor for youth workforce and education programs surrounding Signing Day ultimately led to Gateway's inclusion of former Advantage Coastal Alabama (ACA) investors, which expanded capital and increased fulltime staffing. The coming together of South Baldwin and Coastal Alabama Chamber supporters fully vested the region in the Gateway mission, programs, and vision.

As we move forward, through the COVID-19 Pandemic, we believe that customer service training will become more important than ever. Marketing our "Gulf Coast" brand as one committed to service excellence, southern hospitality, and with additional emphasis on safety will be paramount as we compete with

other destinations over the coming months and years. In some cases, businesses will be hiring entirely new teams with the goal of teaching them a new service culture and set of protocols for protecting guests and employees. Over the course of recovery, our businesses can take advantage of Gateway's established apprenticeship program, professional development opportunities through AIDT, Auburn/ATN, and Gateway originals, like Gateway to Great Customer Service and a soon-to-launch Alabama Restaurant Hospitality Promise (a COVID-19 safety certification program; likely of particular importance to the snowbird market; see page 10 for more on the Gateway Training Academy).

Team participation as leaders in the Alabama Committee on Credentialing and Career Pathways (ACCCP) for the Hospitality & Tourism Career Cluster has also garnered strength and focus on our region's key industries. The Gateway team created new career paths for the state in Hotel & Resort Management and Restaurant & Foodservice Management. These pathways include career exploration in the 8th and 9th grade, industryrecognized academic and apprenticeship credentialing opportunities through high school including strong opportunities for dual enrollment with Coastal Alabama Community College (CACC), plus articulated transfer opportunities to bachelor programs offered in the state. The attached graphic (see page 9) shows the career pathways developed by the Gateway team; this was presented to the Board of the Alabama Restaurant & Hospitality in November 2019 and was Association approved unanimously. This model has been presented to the ACCCP committee for approval at the State level.

The Gateway team is hard at work on new and improved programming designed to promote business acceleration and incubation, namely on the new Foley campus that is The Baldwin Center for Business Development (BCBD; see page 11 for BCBD info). The goal is to make these programs available to complement our economic recovery from COVID-19. Recently. the Gateway team has submitted proposals to Governor and representatives Washington D.C. for funding and support for programs to be offered in the new center. programs that will serve individuals across the entire county, and even beyond. Also in the works for the new center: an entire wing...

dedicated to career skills training classroom space (as well as a warehouse adjacent to the campus to be used as a technical training facility) through CACC. As well, strong advocacy campaigns are in the works to recruit the Foley Career Center to relocate into the space as well as requests for funds to renovate a wing for coworking workspace and incubation services.

We'd be remiss to not mention that over the past few months, Gateway has launched an enhanced website featuring professional videos and articles from community and business leaders, addressing key issues affecting us today and telling the *Baldwin Story*. Gateway will continue producing video content (through collaboration with media partner One Baldwin) in an effort to educate the world about the rich entrepreneurial spirit of Baldwin County. The Gateway Initiative is also quickly becoming interwoven within the region, embracing local programs and services such as Main Street

<u>Foley</u>, online adult education opportunities, the young professionals organization, Lemonade Day, Junior Ambassadors, Junior Leadership, and incubation services like <u>Innovation PortAL</u> and <u>Hatch</u>.

We know we haven't been able to see many of you face-to-face over the past several months, so please know that we continually function with you in mind! We are looking at ways to host an investor event this fall, possibly virtually, to give you as close to an in-person update as appropriate, and give you the opportunity to give us feedback, ask questions, and even share a few laughs! So much has changed in this world, and we understand that means you've likely experienced challenges and made serious choices. We are always here to help and look forward to doing so. Here's to a very bright future and many years of continued success and collaboration in Baldwin County.




