GENERAL

<u>Voting Administration - Declaration of Emergency Warranting Relocation of Voting Place for Baldwin County Voting Precinct No. 49: and</u>

Wayne Dyess, County Administrator, explained the staff request before the Commission.

Motion by Commissioner Ball, seconded by Commissioner Davis, pursuant to correspondence from the Baldwin County Judge of Probate, the Honorable Harry D'Olive, dated September 21, 2020, informing the Baldwin County Commission that due to extensive damage caused by Hurricane Sally on September 15-16, 2020, at the Fairhope Avenue Baptist Church (voting place for Baldwin County Voting Precinct 49), the facility is unable to be utilized by the general public at this time. Consequently, take the following actions:

- 1) Declare an emergency exists warranting the temporary relocation (for November 3, 2020, General Election only) of the Voting Place for Baldwin County Voting Precinct No. 49 from the Fairhope Avenue Baptist Church to the Homestead Village of Fairhope (Ballroom), located at 924 Plantation Boulevard, Fairhope, Alabama, as such relocation is within ninety (90) days of an election; and
- 2) Authorize the Chairman to execute correspondence informing the voting place(s) involved of the changes affecting voting in Baldwin County, Alabama; and
- 3) Authorize the Chairman to execute correspondence to all county election officials (Probate Judge, Sheriff, Absentee Election Manager and Board of Registrars) informing them of the new and temporary relocation of the Voting Place for Baldwin County Voting Precinct No. 49; and

4) Authorize the Chairman to execute correspondence to the Board of Registrars ordering them to immediately issue new voting cards for the affected voters of Baldwin County Voting Precinct No. 49.

Motion by Commissioner Gruber, seconded by Commissioner Ball, related to, and consistent with, the Declaration of the State and Local Emergency declared on September 14, 2020, due to the excessive damage from Hurricane Sally presenting an emergency affecting public safety concerns for the traveling public and residents, award Competitive Bid #WG20 -54 - Emergency Purchase and Installation of one (1) new Portable Truck Scale for the MacBride Landfill to the lowest bidder, G. T. Michelli Co., Inc., in the bid amount of \$54,425.10 and authorize the Chairman to execute the Contract. (Completion time is 14 days from the date the Notice to Proceed is issued).

Disaster Consulting Services Request for Proposals (RFP)

Zach Hood, EMA Director, explained staff's request for the request for proposals for disaster consulting services.

Wanda Gautney, Purchasing Director, explained timelines and process for the proposed bid; this would

have to go through the regular bid process, it does not qualify for the emergency bid process.

Further discussion followed regarding the need for disaster consulting services, the benefits it would bring to the County, the importance of having these services in the future and the current issues in Baldwin County related to housing and long-term recovery due to Hurricane Sally.

Motion by Commissioner Ball seconded by Commissioner Davis, authorize staff to advertise a Request for Proposals (RFP) and solicit bids for disaster consulting services for preparedness, response, planning, recovery, and mitigation services to assist the efforts for recovery from Hurricane Sally and with future disaster impacts caused by threats and hazards identified as a risk for Baldwin County.

Commissioner Davis noted he wants to make sure that other agencies, both federal and state, know that Baldwin County is doing this and that the County expects them to support its efforts in this going forward.
