**Background:** The temporary committee was created by the Baldwin County Commission on January 17, 2017, with an effective date of January 17, 2017 and termination date of December 31, 2019. Thirteen (13) members, selected by the Archives Director, were appointed to the committee by the Commission on January 17, 2017. The committee ended with only eleven (11) members, serving. Ms. Jo Ann Flirt, former Director of Blakeley State Park, passed away February 2, 2018, and Ms. Shannon Spivey resigned from the committee due to work responsibilities. Ms. Spivey and her staff continued to assist the committee on as many Bicentennial projects as possible over the past three years.

The committee was appointed to support, create, and execute events and activities in Baldwin County that commemorate Alabama's 200<sup>th</sup> Anniversary of Statehood.
