### ITEM TITLE

Submission of Fiscal Year 2020 Section 5307 Urbanized Public Transportation Grant Application

### STAFF RECOMMENDATION

Take the following actions:

1. Adopt Resolution No. 2019-102 authorizing the Baldwin County Commission to commit up to \$293,231.00 as local non-federal match for operations, planning, and capital expenditures under the Section 5307 Urbanized Area Public Transportation Program during Fiscal Year 2020; and
2. Adopt Resolution No. 2019-103 authorizing the execution and submittal of a Fiscal Year 2020 Section 5307 Grant Application to the Alabama Department of Transportation (ALDOT) relating to public transportation; and
3. Authorize the Chairman to sign the application and any related documents, any related award documents, and any related reporting documents; and
4. Authorize Baldwin Regional Area Transit System (BRATS) staff to submit the Fiscal Year 2020 Section 5307 agreement to ALDOT.

### BACKGROUND INFORMATION

Previous Commission action/date: N/A

**Background:** BRATS qualifies to receive annual Section 5307 grant funding from the Federal Transit Administration, which passes through ALDOT. The funds are used to provide mass public transportation to the citizens and visitors of Baldwin County.

As with most federal grants, the BRATS public transit grants go through an annual application process. Because a portion of the BRATS service area falls within the Eastern Shore Metropolitan Planning Organization (MPO), BRATS is required split its costs between the two areas and submit both an urban (5307) and rural (5311) grant. These grant requests are intentionally conservative (on the high side) to ensure that sufficient funds are awarded to provide the Commission with maximum flexibility for operating BRATS. The dollar amounts in these grants **do not represent** the actual expenses approved in the County budget. The Commission will approve the BRATS Fiscal Year 2020 budget separately during the annual budget process.

The Fiscal Year 2020 request for federal assistance is \$820,041.00 and the local match requirement estimated at up to \$293,231.00, depending on the budget ultimately approved by the Commission. \$174,000.00 of the local matching funds would be covered by local municipalities on the Eastern Shore for proposed transit hubs in those locations.

These federal funds are 80% of Capital and Planning Cost and 50% of Operational cost. A Public Hearing has been advertised for and will be held on June 17, 2019, at 9:00 a.m. in the Baldwin County Commission BRATS office in Robertsedale, Alabama, to allow for comments on the proposed transportation service.

The application deadline is June 28, 2019. BRATS staff has submitted an unsigned copy of the application to ALDOT and if approved, the signed original application will be overnighted to ALDOT on June 18, 2019.

The final grant application is/contains proprietary information, so it is marked confidential.

**Total cost of recommendation:** \$1,113,272.00 with \$820,041.00 offset by 5307 Grant Revenue, \$29,990.00 offset by Farebox Revenue, \$10,803.00 offset by Contract Revenue resulting in up to \$252,438.00 in Local Match, depending on the budget ultimately approved by the Commission.
