STAFF RECOMMENDATION

Take the following actions:

- 1) Approve and authorize the Chairman to execute the attached Professional Service Agreement for Trap-Neuter-Return (TNR) Services with Magnolia by the Gulf Animal Clinic. This agreement commences on September 18, 2018, and continues for a period of ninety (90) days (expiring on December 17, 2018) with an automatic renewal for one additional ninety (90) day term (expiring March 17, 2019); and
- 2) Approve and authorize the Chairman to execute the attached Veterinary Services Agreement between the Baldwin County Commission and Magnolia by the Gulf Animal Clinic. This agreement commences on September 18, 2018, and continues for a period of two (2) years (expiring on September 18, 2020) with an automatic renewal for one (1) year (expiring September 18, 2021).
