STAFF RECOMMENDATION

Approve License Agreement #18021 permitting Candese Olan to clear approximately 480' x 30' of underbrush and a few small trees less than 8" in diameter, to install a 24" HDPE drive pipe and to construct a driveway to access the property off Cypress Avenue. The driveway will be maintained by the licensee for the portion of right-of-way that is not County maintained.
