### STAFF RECOMMENDATION

Approve the requested route for the Optimist Club of Perdido Bay's 28th Annual Lillian Christmas Parade on Saturday, December 8, 2018, beginning at 1:00 p.m. on Widell Street, proceeding northeast on U.S. Highway 98, north on 6<sup>th</sup> Street, west on West Barclay, then south on Santa Pedro Street, back to the point of beginning. The parade is 1 ¼ miles long and will take approximately 1 hour and 15 minutes to complete.

The Baldwin County Sheriff's Office will provide security and the Department of Public Safety, Highway Patrol Division, will handle the road closure for this event.
