**Background:** In the immediate aftermath of Hurricane Michael that devastated areas of the Florida

panhandle, Baldwin County Emergency Management Agency (EMA) received a request to house 120 special needs residents and caregivers from an assisted living facility out of Okaloosa, Florida. The Commission took action during its October 11, 2018, Emergency Special Meeting to accommodate the request by continuing to the operation of the Baldwin County Coliseum as a shelter until November 13, 2018. Baldwin County EMA staff was notified by the State of Alabama Emergency Management Agency (AEMA) on October 12, 2018, that the Coliseum was no longer needed as a shelter. Preparations for shelter opening had begun at that time, but no residents were transported to the shelter.
