conditions stated in the bid specifications as awarded on February 7, 2017. The extension will expire on February 7, 2019.

Background: The CIS Department is requesting that the Commission extend the bid for the Provision of Telecommunication Materials with Graybar Electric Company that was awarded on February 7, 2017, for twelve (12) months. The bid specifications contained a stipulation that the bid could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendor.
