BACKGROUND INFORMATION

Previous Commission action/date: October 3, 2017

Background: The Baldwin County Commission submitted a letter of support for the I-10 Mobile River Bridge and Bayway Project on October 3, 2017, which was included in ALDOT's grant application package to the U.S. Department of Transportation for the project.

On January 25, 2019, staff received correspondence from the Alabama Department of Transportation requesting a letter for the Baldwin County Commission's on-going support of the Interstate 10 Mobile River Bridge and Bayway Project.
