### STAFF RECOMMENDATION

Adopt Resolution #2019-040 and an Intergovernmental Service Agreement between the City of Fairhope and Baldwin County for the transfer of maintenance of **Kirkman Lane** from Marietta Drive to approximately 396 feet east of Marietta Drive, **Kirkman Lane North** from Kirkman Lane to approximately 210 feet north of Kirkman Lane and **Taylor Street** from Main Street to end of maintenance.
