Award bid #WG19-29 - Provision of Ready Mixed Concrete to the lowest bidder, **Ready Mix USA**, as per the attached Award Listing.

BACKGROUND INFORMATION

Previous Commission action/date:

03/19/19 meeting: 1) Approved the specifications and authorized the Purchasing Director to place a competitive bid for the Provision of Ready Mixed Concrete; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

Background: Bids were opened in the Purchasing Conference Room on April 11, 2019. Two (2) bids were received. The apparent low bidder is Ready Mix USA. The Highway Department primarily uses 2500, 3000 and 4000 mixes. Even with the extra charges, Ready Mix USA is lower on 3 out of 5 mixes. Recommendation is to award to the lowest bidder, Ready Mix USA as per the attached Award Listing.
