Related to Baldwin County Commission's basic banking services with Hancock Whitney Bank, authorize the Interim Clerk/Treasurer to accept the (3) month extension with the same terms and conditions as was approved by the Commission on April 5, 2019. The extension period is June 1, 2019, to August 31, 2019.

Previous Commission action/date: April 5, 2016

Background: During the Baldwin County Commission meeting held on April 5, 2016, the following actions were taken:

- Awarded basic banking services to Hancock Bank For the period of June 1, 2016 to May 31, 2019, with two (2) 12-month options, at an interest rate listed to the 90-day treasury bill plus 0.12% with a floor of 0.63% and the Commission will the bank service fees; and
- 2. Awarded the Baldwin County Merchant Services to Hancock bank for the period of June 1, 2016 to May 31, 2019, with two (2) 12-month options, at a cost-plus price with a discount rate of 0.0% and transaction fee of \$0.10; and
- 3. Awarded the Baldwin County Commission Lockbox Services to Hancock Bank for the period of June 1, 2016 to May 31, 2019. With two (2) 12-month options, and the Commission will pay
