Background: The Baldwin County Solid Waste Department is requesting that a Request for Proposals (RFP) be advertised for companies interested in developing a landfill gas-to-energy project at the Magnolia Sanitary Landfill, an active municipal solid waste landfill in Baldwin County, Alabama.
