STAFF RECOMMENDATION

Take the following actions:

1. Accept 0.517 acres on Brewer Road from County Road 65 to Poser Road (Tract 13) as a right-ofway donated to Baldwin County by Frances Holk-Jones on August 14, 2019 (Instrument No. 1778076 of Baldwin County Judge of Probate); and

2. Related to the aforesaid, authorize the Chairman to execute IRS Form 8283 for the donated rightof-way.

Background: On August 14, 2019, the Baldwin County Highway Department accepted a right-of-way donation on Brewer Road from Ms. Frances Holk-Jones.

By the Chairman executing the IRS Form 8283, the County is not indicating that it agrees with the valuation of the property, but rather the County is acknowledging the fact that the County did receive
