Competitive Bid #WG17-31 - Provision of Soft Body Armor for the Baldwin County Sheriff's Department

### STAFF RECOMMENDATION

Extend the Contract for Competitive Bid #WG17-31 - Provision of Soft Body Armor for the Baldwin County Sheriff's Department with Gulf States Distributors and Gall's LLC, for an additional twelve (12) months at the same prices and terms stated in the bid specifications as awarded on November 7, 2017. The extension will expire on November 7, 2020.

### BACKGROUND INFORMATION

### Previous Commission action/date:

<u>09/05/2017 meeting</u>: 1) Approved the specifications for the Provision of Soft Body Armor for the Baldwin County Sheriff's Department and authorized the Purchasing Director to place a competitive bid; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

<u>11/07/2017 meeting:</u> Awarded the bid for the Provision of Soft Body Armor for the Baldwin County Sheriff's Department to Gulf States Distributors and Gall's LLC, as per the attached Award Listing.

<u>11/06/2018 meeting</u>: Extended the Contract for Competitive Bid #WG17-31 - Provision of Soft Body Armor for the Baldwin County Sheriff's Department with Gulf States Distributors and Gall's LLC, for an additional twelve (12) months at the same prices and terms stated in the bid specifications as awarded on November 7, 2017. The extension will expire on November 7, 2019.

**Background:** The Sheriff's Department is requesting that the Commission extend the bid for the Provision of Soft Body Armor for the Baldwin County Sheriff's Department with Gulf States Distributors and Gall's LLC, that was awarded on November 7, 2017 for an additional twelve (12) months. The bid specifications contained a stipulation that the bid could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendors. Any additional contract or extensions will be at the same prices, terms and conditions stated in the bid. The vendors, Gulf States Distributors and Gall's LLC, have submitted an email agreeing to extend the bid prices for an additional twelve (12) months. The extension will expire on November 7, 2020.
