- 2) Approve the promotion of Fred Dishaw from the Solid Waste Driver II position (PID #5394) grade I-11 (\$20.499 per hour / \$42,637.92 annually) to fill the open Solid Waste Driver III position (PID #5506) grade J-10 (\$21.956 per hour / \$45,668.48 annually); and
- 3) Approve the promotion of Brian Philyaw from the Solid Waste Driver II position (PID #5396) grade I -08 (\$19.045 per hour / \$39,613.60 annually) to fill the open Solid Waste Driver III position (PID #5505) grade J-07 (\$20.404 per hour / \$42,440.32 annually); and

- 7) Approve the promotion of Joey Morris from the Landfill Equipment Operator III position (PID #378) grade I-19 (\$24.972 per hour / \$51,941.76 annually), at the Solid Waste Transfer Station (54325) to fill the open Landfill Equipment Operator IV position (PID #5501) grade J-18 (\$26.765 per hour / \$55,671.20 annually) at the Magnolia Landfill (54300).
