### BACKGROUND INFORMATION

#### **Previous Commission action/date:**

12/17/2019 meeting: 1) Approved the specifications and authorized the Purchasing Director to place a competitive bid for the Provision of Fence Installation and Repair on County Right-of-Ways for the Baldwin County Commission; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

**Background:** Bids were opened in the Purchasing Conference Room on January 6, 2020 at 2:00 P.M. Three (3) bids were received. The lowest bid was received from Warriner Construction who did not include the required Certificate of Insurance and a Bid Bond. The next lowest bid who met all

the specifications was received from S & S Construction Services, LLC. Recommend the Commission award the bid to the lowest responsible bidder, **S & S Construction Services, LLC**, as per the attached Award Listing for the Provision of Fence Installation and Repair on County Right-of-Ways.
