**Background:** The Probate Court Division located in Bay Minette rental agreement for their current copy machine has expired. Sharp Electronics Corporation has submitted a rental agreement to replace the copy machine with a new machine. The rental agreement is for thirty-six (36) months and will be leased off the State of Alabama bid. The copy machine rental includes all supplies, toner

and developer. The new cost proposal will be \$159.38 per month. This is a cost savings of \$408.48 per year.
