- 3) Recognize Thurston Bullock as the Chairman of the Baldwin County Personnel Appeals Board; and
- 4) Recognize Megan Hart as Secretary of the Baldwin County Personnel Appeals Board.

Background: Under the statutory authority of Section 45-2-120, et. seq., of the <u>Code of Alabama</u>, an election was held to fill the expired term of Personnel Appeals Board Member, Matthew Brown. This Board is composed of five (5) members: two (2) members are appointed by the Commission, two (2) members are elected by county classified employees, and one (1) is selected by the other four (4) members. Upon the completion of the voting process, Matthew Brown was re-elected to fill the three (3) year term, with the term ending at close of business on December 31, 2019. Under the above noted statutory authority, a written certification signed by all employees who assisted in ballot tabulation is required to be sent to the Baldwin County Legislative Delegation.
