STAFF RECOMMENDATION

Approve Amendment No. 1 to the Contract between Baldwin County Commission and CrowderGulf, LLC, for the Pre-Event Debris Removal and Disposal Services from the County Right-of-Ways within Unincorporated Baldwin County, in the amount of **\$6.45 per pound** to pick-up and haul household hazardous waste to disposal locations.

BACKGROUND INFORMATION

<u>05/15/2018 meeting:</u> Awarded Bid #WG18-18 - Pre-Event Removal and Disposal Services from the County Right-of-Ways within Unincorporated Baldwin County to the lowest responsible bidder, which met all the specifications, CrowderGulf, LLC, as per the attached bid tabulation and authorized the Chairman to execute the Contract. (Contract shall be effective and commence immediately upon the same date as its full execution.)

<u>03/17/2020 meeting:</u> Extend Competitive Bid #WG18-18 - Pre-Event Debris Removal and Disposal Services from the County Right-of-Ways within Unincorporated Baldwin County, with CrowderGulf, LLC, for an additional twelve (12) months at the same prices, terms and conditions stated in the original bid specifications that was awarded on May 15, 2018. The Contract extension will expire on May 15, 2021

Background:

CrowderGulf, LLC, has submitted Amendment No. 1 for Commission approval to the current Contract for the County's Pre-Event Debris Removal and Disposal Services from the County Right-of-Ways within Unincorporated Baldwin County. The County has received calls from county citizens regarding hazardous waste materials that was washed up on County right-of-ways from Hurricane Sally. The cost submitted from CrowderGulf, LLC, to pickup and haul the hazardous waste to a disposal location is \$6.45 per pound.
