<u>9/1/2020 meeting</u>: 1) Approved the specifications and authorized the Purchasing Director to place a competitive bid for the Purchase of Three (3) New Steel Storage Containers; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid was advertised.

<u>10/6/2020 meeting</u>: 1) Authorized the Purchasing Director to re-bid for the Purchase of Three (3) New Steel Storage Containers for the Baldwin County Commission; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid was advertised.

**Background:** Bids were opened in the Purchasing Conference Room on October 21, 2020 at 1:30 P.M. One (1) bid was received, from Quick Buildings Modular, LLC in the amount of \$8,530.00 per

unit for a total of \$25,590.00 for three (3) containers. Staff recommendation is to reject the bid and pursue the purchase of the storage containers at a later date because the bid amount exceeded the amount budgeted for this purchase.
