### STAFF RECOMMENDATION

Adopt Resolution #2021-037 amending the Fiscal Year 2021 Budget (Resolution #2020-126 and Resolution #2020-127, adopted September 22, 2020) to authorize the roll forward of FY20 project funds to FY21 for Funds 111, 115, and 165 and the funding of the County Road 6 property purchase.

### BACKGROUND INFORMATION

**Previous Commission action/date:** Fiscal Year 2021 Budget was passed on September 22, 2020. The County Road 6 property purchase was approved on December 15, 2020.

**Background:** The Fiscal Year 2021 Budget was passed on September 22, 2020 via Resolution #2020-126 and Resolution #2020-127. The Highway Department respectfully requests that FY20 budgeted project funds from Funds 111, 115, and 165 be rolled forward to FY21. The County Road 6 property purchase was approved on December 15, 2020. Budget staff respectfully requests that the General Fund - Fund Balance funds be adjusted to fund the purchase.
