STAFF RECOMMENDATION

Take the following actions:

- 1) **Reject** the bid received and authorize the Purchasing Director to re-bid for the construction of one (1) new 40 ft. x 60 ft. pole barn to be located at the Bicentennial Park in Stockton, Alabama because the bidder does not have an Alabama General Contractor's License and did not submit a bid guarantee as is required by state law; and
- 2) Further, authorize the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

BACKGROUND INFORMATION

Previous Commission action/date:

12/01/2020 meeting: 1) Rejected the bid received and authorized the Purchasing Director to re-bid for the construction of one (1) new 40 ft. x 60 ft. pole barn to be located at the Bicentennial Park in Stockton, Alabama because the bid amount exceeded the amount budgeted for this project; and 2)

Further, authorize the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

10/20/2020 meeting: 1) Approved the specifications and authorized the Purchasing Director to place a competitive bid for the construction of one (1) new 40 ft. x 60 ft. Pole Barn to be located at the Bicentennial Park in Stockton, Alabama for the Baldwin County Commission; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid was advertised.

Background: Bids were opened in the Purchasing Conference Room on January 5, 2021 at 1:30 p. m. One (1) bid was received, but the bidder does not have an Alabama General Contractor's License as is required by the Code of Alabama 1975, Section 34-8-1, and did not submit a bid guarantee as is required by the Code of Alabama 1975, Section 39-2-4. Staff recommends the Commission authorize the Purchasing Director to re-bid the project.
