STAFF RECOMMENDATION

Take the following actions:

1) Accept 0.034 acres on Brantley Lane (Tract 2) as a right-of-way donated to Baldwin County by the Estate of Deidre White Lee on June 17, 2020 (Instrument No. 1836949 of Baldwin County Judge of Probate); and

2) Related to the aforesaid, authorize the Chairman to execute IRS Form 8283 for the donated rightof-way.

BACKGROUND INFORMATION

Previous Commission action/date: N/A

Background: On June 17, 2020, the Baldwin County Highway Department accepted a right-of-way donation on Brantley Lane from the Estate of Deidre White Lee.

By the Chairman executing the IRS Form 8283, the County is not indicating that it agrees with the valuation of the property, but rather the County is acknowledging the fact that the county did receive

the property.

The only part of the form that will be signed by the Chairman is Part IV, Donee Acknowledgement, in which:

1) The date of receipt of the donation is acknowledged; and

2) The County affirms that it will file an IRS information return should it dispose of the property within two (2) years after the date of receipt; and

3) The County states whether it intends to use the property for an unrelated use.
