# STAFF RECOMMENDATION

1) Accept 0.339 acres on Brantley Lane (Tract 3) as a right-of-way donated to Baldwin County by J.H. Weeks and Janet Weeks on July 9, 2020 (Instrument No. 1841682 of Baldwin County Judge of Probate); and

2) Related to the aforesaid, authorize the Chairman to execute IRS Form 8283 for the donated rightof-way.

**Background:** On July 9, 2020, the Baldwin County Highway Department accepted a right-of-way donation on Brantley Lane from J.H. Weeks and Janet Weeks.

By the Chairman executing the IRS Form 8283, the County is not indicating that it agrees with the valuation of the property, but rather the County is acknowledging the fact that the county did receive
