STAFF RECOMMENDATION

Approve the following Amendments to the Emergency Rental Assistance Program Guidelines:

- 1) Amendment #1: Payments made directly to renters when landlords refuse to participate.
- 2) Amendment #2: Include utilities, late fees, relocation expenses, and reconnection fees.
- 3) Amendment #3: Revise program deadline to September 30, 2022; and application submission deadline to June 10, 2022.
