(Expiration date of SAPA Bid is July 31, 2022).

BACKGROUND INFORMATION

Previous Commission action/date:

<u>05/04/2021 meeting</u>: 1) Approved the specifications and authorized the Purchasing Director to place a competitive bid for the Provision of Regular Unleaded Gasoline and No. 2 Diesel Fuel; and 2) Further, authorized the Chairman/Purchasing Division Commissioner for the Baldwin County Commission to approve any necessary addendums or clarifications if required after the bid is advertised.

Background: Bids were opened in the Purchasing Conference Room on June 2, 2021, at 1:30 p.m. Three (3) bids were received. Staff is requesting that Commission reject all the bids received on June 2nd and allow staff to utilize the SAPA (South Alabama Purchasing Association) Bid to purchase the fuel from Davison Oil Company, Inc., for the next twelve (12) months.
