## STAFF RECOMMENDATION

Related to the Employment Contracts between the Baldwin County Commission and the Appointed Contract Employees, take the following actions:

## 1) Budget Director - Considerations Related to Employment Contract

Authorize and approve the execution of the First Amendment to Employment Contract between the Baldwin County Commission and Ronald J. Cink applicable to the position of Budget Director, which increases the annual compensation to \$126,967.50. This First Amendment will be effective on September 21, 2021.

## 2) Building Official - Considerations Related to Employment Contract

Authorize and approve the execution of the Second Amendment to Employment Contract between the Baldwin County Commission and Eddie D. Harper applicable to the position of Building Official, which increases the annual compensation to \$99,275.00. This First Amendment will be effective on September 21, 2021.

## 3) Clerk/Treasurer - Considerations Related to Employment Contract

Authorize and approve the execution of the First Amendment to Employment Contract between the Baldwin County Commission and Adria Cian Harrison applicable to the position of Clerk/Treasurer, which increases the annual compensation to \$117,562.50.
