September 21, 2021 - The Commission adopted Resolution #2021-128 and approved the FY 2022 budget allocating \$175,000.00 for design of the County Road 65 Extension Project.

**Background:** The Highway Department has selected Mott MacDonald Alabama, LLC to prepare plans and specifications for the County Road 65 Extension Project. The proposed fee of \$174,803.00 exceeds the \$100,000.00 limit outlined in Baldwin County Policy #9.10.
