Competitive Bid #WG22-57 - Construction of Magnolia Sanitary Landfill Cell 9 Located in Summerdale, Alabama for the Baldwin County Commission

STAFF RECOMMENDATION

Award the bid to the lowest bidder, **Atlantis Commercial Group, Inc., in the amount of \$4,411,140.00; Construction Time: 210 calendar days;** for the construction of Magnolia Sanitary Landfill Cell 9 located in Summerdale and authorize the Chairman to execute the Contract and all other award documents.

BACKGROUND INFORMATION

Background: Bids were opened in the Purchasing Conference Room on August 9, 2022, at 10:00 A.M. Three (3) bids were received. The lowest bid was received from Atlantis Commercial Group, Inc., in the amount of \$4,411,140.00. The Engineer, Daniel Wells, with CDG Engineering and Associates reviewed the bid responses and has submitted the certified Bid Tabulation and letter recommending that the bid be awarded to the lowest bidder, Atlantis Commercial Group, Inc., in the amount of \$4,411,140.00.
