STAFF RECOMMENDATION

Extend Competitive Bid #WG20-52A - Provision of Push-to-Talk over Cellular (PoC) Services & Equipment Monthly Rental with **Two-Way Communications**, **Inc.**, for an additional twelve (12) months at the same prices and terms stated in the original bid award on December 1, 2020. The new extension will expire on December 1, 2023.

BACKGROUND INFORMATION

Background: Staff is requesting the Commission extend the bid for the Provision of Push-to-Talk over Cellular (PoC) Services & Equipment Monthly Rental that was awarded to Two-Way Communications, Inc., on December 1, 2020, for twelve (12) months. The bid specifications contained a stipulation that the bid could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendor. Any additional contract or extensions will be at the same prices, terms and conditions stated in the bid. The vendor, Two-Way Communications, Inc., has submitted an email agreeing to extend the bid prices for an additional twelve (12) months. The new extension will expire on December 1, 2023.
