Competitive Bid #WG22-12 - Provision of Guardrail Installation and Repair on County Right-of-Ways for the Baldwin County Commission

STAFF RECOMMENDATION

Extend the Contract for Competitive Bid #WG22-12 - Provision of Guardrail Installation and Repair on County Right-of-Ways with **C & H Construction Services**, **LLC**, for an additional twelve (12) months at the same prices and terms stated in the bid specifications as awarded on January 18, 2022.

The Contract extension will expire on January 18, 2024.

BACKGROUND INFORMATION

Background: The Highway Department is requesting that the Commission extend the bid for the Provision of Guardrail Installation & Repair on County Right-of-Ways with C & H Construction Services, LLC, that was awarded on January 18, 2022, for twelve (12) months. The bid specifications contained a stipulation that the bid could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendor. Any additional contract or extensions will be at the same prices, terms and conditions stated in the bid. The vendor, C & H Construction Services, LLC, has submitted an email agreeing to extend the bid prices for an additional twelve (12) months. The Contract extension will expire on January 18, 2024.
