STAFF RECOMMENDATION

Adopt Resolution #2023-082, which approves Case No. Z23-4, Turner Property, as it pertains to the rezoning of 17.08 +/- acres, more or less, as located in Planning (Zoning) District 32, from RSF-2, Single Family District and RMF-6, Multiple Family District to RSF-E, Residential Single Family Estate District.

Background: The subject property is currently zoned RSF-2, Single Family District and RMF-6, Multiple Family District. The subject property is located south of US Highway 98, east of County Road 95, on the South side of Josephine Drive. The adjacent properties are residential and rural.
