BACKGROUND INFORMATION

Background:

The Gross Guarantee for the Highway Department auction equipment is \$36,900.00. Per the contract, there will be a 6% commission deducted from the proceeds.

Previous Commission action/date:

February 7, 2023 - The Commission approved and authorized the Chairman to execute the list of Highway Department equipment for sale by auction (Exhibit A) at the J.M. Wood Auction Company, Inc. facility in Montgomery, Alabama on March 21-24, 2023, or June 13-15, 2023.

December 20, 2022 - The Commission approved and authorized the Chairman to execute the Auction Sales Agreement between J.M. Wood Auction Company, Inc., and the Baldwin County Commission, which will be applicable to all departments of the Commission, with all future equipment

inventory lists being brought to the Commission for approval. This agreement shall become effective December 20, 2022, pending full execution by both parties, and terminate December 31, 2023, with an automatic renewal for an additional two (2) years, in one (1) year increments, unless cancelled by either party with a 30-day written notice prior to the contract renewal.
