STAFF RECOMMENDATION

Take the following actions:

- 1) Approve Change Order #1 with Atlantis Commercial Group, Inc., for the construction of Magnolia Sanitary Landfill Cell 9 located in Summerdale, Alabama; and
- 2) Authorize the Chairman to execute the Change Order #1 in the amount of \$412,734.49. Construction time will be increased 135 calendar days.

BACKGROUND INFORMATION

Background: The engineer, Daniel Wells, is submitting for Commission approval Change Order #1 in the amount of \$412,734.49 for the construction of Magnolia Sanitary Landfill Cell 9 located in Summerdale, Alabama. The Change Order will increase the construction time by 135 calendar days for the additional work. The Change Order is for cost associated with extension of Cell 10 tie-in on north and south ends; modifications to north and south pump station manholes; additional 60' bore under existing driveway for leachate force main; retaining wall and concrete pad around north and south pump stations and entrance road extension and retention pond install. The original construction cost of this project was \$4,411,140.00. With the addition of Change Order #1 the new

construction cost will be \$4,823,774.49.

<u>08/16/2022 meeting:</u> Awarded the bid to the lowest bidder, Atlantis Commercial Group, Inc., in the amount of \$4,411,140.00; Construction Time: 210 calendar days; for the construction of Magnolia Sanitary Landfill Cell 9 located in Summerdale and authorized the Chairman to execute the Contract and all other award documents.
