STAFF RECOMMENDATION

Award Bid #WG23-32 to the lowest bidder, **Sun Coast Builders, Inc.**, for the Purchase and Installation of one (1) new 40 ft. X 132 ft. X 18 ft. Metal Building for the Baldwin County Sheriff's Office located in Robertsdale, Alabama, per the award listing and authorize the Chairman to execute the contract.

Contract is effective for 120 days after the Notice to Proceed is issued.

BACKGROUND INFORMATION

Background: Bids were opened in the Purchasing Conference Room on May 3, 2023, at 2:00 P.M. Six (6) bids were received. Staff recommends the Commission award the lowest bidder, Sun Coast Builders, Inc., for the purchase and installation of one (1) new 40 ft. X 132 ft. X 18 ft. Metal Building for the Baldwin County Sheriff's Office located in Robertsdale, Alabama, in the bid amount of \$126,954.00 and have the Chairman execute the Contract. The Commission budgeted \$75,000.00 during FY2023 for the construction of this building. The Baldwin County Sheriff's Office has agreed to pay the Commission the remaining funding of \$51,954.00 needed to complete this project. Bid Tabulation attached for review.
