#### **ITEM TITLE**

Contract Extension for Professional Services to Support IBM I Servers (AS400) for the Baldwin County Commission

# STAFF RECOMMENDATION

Extend the Professional Services Contract with David Pimperl for consulting services to assist with the system administration and support of the County's IBM I Servers (AS400), at a cost of \$85.00 per hour, not to exceed 15 hours per month, for an additional twelve (12) months at the same terms and conditions as stated in the original Contract award on October 3, 2017. The Contract extension will expire on October 3, 2019.

# **BACKGROUND INFORMATION**

#### Previous Commission action/date:

October 3, 2017, meeting: Authorized the Chairman to execute a Contract for professional services between the Baldwin County Commission and David Pimperl for Consulting Services to assist with the system administration and support of the County's IBM I Servers (AS400), at a cost of \$85.00 per hour, not to exceed 15 hours per month. (Contract shall be effective for twelve (12) months commencing immediately upon the same date as its full execution, with an option to issue two (2) twelve (12) month Contract extensions, or extend the first Contract until such a time a new Contract can be bid and awarded.)

**Background:** The Commission approved during their October 3, 2017, regular meeting a Professional Services Contract for Consulting Services with David Pimperl to assist with the system administration and support of the County's IBM I Servers (AS400), at a cost of \$85.00 per hour, not to exceed 15 hours per month for twelve (12) months. These services are an extension of the CIS department to support Probate, Revenue, Building Department and Sales Tax along with all departments that utilize the AS400 on a daily basis. The Contract terms contained a stipulation that the services could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendor. Any additional contract or extensions will be at the same prices, terms and conditions stated in the original Contract. The vendor, David Pimperl, has submitted and email agreeing to extend his price for an additional twelve (12) months. The Contract
