## **ITEM TITLE**

DSD Services Group, LLC - Consulting in the Form of Specialized Professional Services Contract

#### STAFF RECOMMENDATION

Approve the first twelve (12) month extension of the Professional Services Contract between the Baldwin County Commission and DSD Services Group, LLC, a limited liability corporation organized and existing under the laws of the State of Alabama and doing business as "DSD Services Group," for consulting support in the form of Specialized Professional Services related specifically to the RESTORE Act and related Deepwater Horizon Oil Spill Restoration Activities.

The Term of this Agreement Extension shall commence on March 6, 2019, and shall continue thereafter for twelve (12) months, with the option to extend the Agreement for one additional term of twelve (12) months, said option to be executed by the Chairman, upon such terms as may be agreed upon by both parties. This Agreement shall be subject to cancellation or termination by either party, with or without cause, upon (30) days written notice to the other.

#### BACKGROUND INFORMATION

**Background:** February 6, 2018 - The Commission approved a new Professional Services Contract with DSD Services Group, LLC. The contract commenced upon its full execution on March 6, 2018, and will expire on March 6, 2019. At this time, the Commission can extend the current contract for a 12-month period if they elect to do so.

June 21, 2016 - The Commission approved the initial contract between the Baldwin County Commission and DSD Services Group, LLC for consulting support in the form of Specialized Profession al Services related specifically to the RESTORE Act and related Deepwater Horizon Oil Spill Restoration Activities.
