Extend Bid #WG21-29 - Provision of Aftermarket Heavy Duty Truck Parts with **FleetPride**, **Inc.**, for an additional twelve (12) months at the same prices and terms as stated in the original bid award approved June 15, 2021. The bid extension will expire on June 15, 2023.

<u>06/15/2021 meeting:</u> Awarded the bid for the Provision of Aftermarket Heavy Duty Truck Parts for the Baldwin County Commission to Fleet Pride, Inc., as per the attached Award Listing.

Background: The Solid Waste Department is requesting that the Commission extend the bid for the Provision of Aftermarket Heavy Duty Truck Parts that was awarded to Fleet Pride, Inc., on June 15, 2021, for twelve (12) months. The bid specifications contained a stipulation that the bid could be extended for two (2) additional twelve (12) month periods by the Commission at their option, if acceptable by the vendor. Any additional contract or extensions will be at the same prices, terms and conditions stated in the bid. The vendor, Fleet Pride, Inc., who was awarded the bid, has submitted an email agreeing to extend the bid prices for an additional twelve (12) months. The current bid prices are attached. The extension will expire on June 15, 2023.
